5. List User must notify the SDSS, within 90 days of receipt of said list; if they are unable to use it or return said list to SDSS. Any unused portions of lists should be destroyed or returned.

6. List user agrees to be solely responsible for, to defend or indemnify, and to hold harmless SDSS from all claims, demands, fines, causes of action, damages and attorney's fees arising from the use of SDSS Lists.
